## Taxpayers Urge American Bankers Association To Support Common Sense Financial Reforms That Will Prevent Another Economic Crash

## THOUSANDS OF TAXPAYERS RALLY OUTSIDE GOLDMAN SACHS AND WELLS FARGO HEADQUARTERS FOR DAY 2 OF 3 AT THE SHOWDOWN IN CHICAGO

Chicago – Thousands of taxpayers rally in Chicago for the second day of the Showdown against big banks. This time, along with the American Bankers Association (ABA) Conference, the targets were also Goldman Sachs and Wells Fargo's Chicago headquarters.

After the morning's speech by FDIC Chair Sheila Bair supporting Obama's Consumer Financial Protection Agency, thousands of Showdown participants arrived at Goldman Sachs Chicago headquarters to try and deliver a demand letter.

"Today, Goldman Sachs officials accepted our letter to Lloyd Blankfein and agreed to get it into his hands," said James Mumm, Director of Organizing, National People's Action. "In this letter we demand that Goldman Sachs stop working against the American people and instead start supporting common sense financial reform. We also showed Blankfein how he can be a hero this holiday season by directing Goldman Sachs take some of its projected \$23 billion bonuses this year and redirect it to foreclosure prevention programs that work to keep people in their homes."

"Wells Fargo is one of the top financiers of predatory pay day lending companies in America," said 81-years old Ferol Wegner of Iowa Citizens for Community Improvement, who lost a third of her pension in the last year. "Their irresponsible lending practices have also led to tens of thousands of foreclosures and vacant buildings in our communities. Wells Fargo is also guilty of targeting African Americans and Latinos with predatory sub-prime loans in our communities."

The Showdown protests continued back at the American Bankers Association conference, where the thousands continue to question why community bankers remain in an association that is lobbying against their interest. Taxpayers continued to demand that the ABA stop lobbying against common sense financial reforms put forth by President Obama.

Later today, they expect to be joined by several thousands more for a march of 8,000 workers, clergy and community leaders, who will send a message to the Congress – **which side are you on** - the side of taxpayers and constituents or the side of lobbyists, big banks, and Wall Street?
